Camping & Picnic Fair 2024 Terms and Conditions

Article 1. Definition of terms

- ① "Exhibitor" refers to the exhibitors, such as an individual, company, institute or group, which has submitted the stipulated participation contract for participating in this exhibition.
- ② "Exhibition" refers to 'Camping&Picnic Fair 2024'.
- ③ "Organizer" refers to 'AllFair'.

Article 2. Exhibition application and Agreement

- ① The one who wish to participate the exhibition shall fill the application form, receive approval from the organizer and pay total participate fee by the date written on the invoice.
- ② After the application registration form being submitted, if the organizer refuses to approve for harmonious constitution and operation of the exhibition, the agreement is not effected.
- ③ In case of any alternation in technical support request, the exhibitor shall inform the organizer in prompt manner. Any disadvantage occurred by the non-inform is subject to the exhibitor's responsibility.

Article 3. Assignment of exhibition booth

- ① Organizer has all rights to the booth assignment and exhibitor may not object to the decision made. According to application, booth will be assigned considering item, size, exhibition results and other reasonable matters.
- ② Exhibitor may not ask for compensation and participation fee is not refundable.

Article 4. Exhibition management

- ① Exhibition shall display the items listed in the application and have someone to take care of the booth at all times.
- ② If the exhibitor displays items not listed in the application or if displayed item does not fit the nature of the exhibition or conducts direct sales without approval from the organizer, organizer can request to stop, withdrawal or dismantle. This case, participation fee is not refundable and exhibitor may not ask for compensation.
- ③ Exhibitor cannot use other area for the exhibit without prior approval from organizer.

Article 5. Payment

- ① Exhibitor shall make an total participation fee by the date written on the invoice.
- ② In the event of exhibitor not making the balance payment within the designated deadline, organizer may cancel the contract and the exhibitor cannot ask for refund.

Article 6. Exhibition cancellation and Penalty

- ① The exhibitor cannot assign the contract, sub-let or part with site or stand or any portion of it without prior written consent from the organizer. If the exhibitor breaches this terms, exhibition can be cancelled and the fee will not be subject to refund.
- ② If the exhibitor does not pay the exhibition fee within the designated period, organizer has the right to cancel the exhibition contract. In this case, exhibitor is not entitled to refund.
- ③ In case the exhibitor cancels or refuses the whole or partial space which is already registered due to own reason, the exhibitor shall inform the organizer in document and pay the penalty. Penalty is deducted from the paid exhibition fee, If not sufficient, the exhibitor shall pay the addition, and if surplus, the balance will be returned. Charges are subject to be paid as follows.

- Cancellation or Reduction of number of booth until DEC 3,2023 : 50% of total participation fee
- Cancellation or Reduction of number of booth from DEC 3,2023 to FEB 2,2024 : 70% of total participation fee
- Cancellation or Reduction of number of booth after FEB 3,2024 : 100% of total participation fee

Article 7. Cancellation of exhibition or Alteration

In the event of cancellation or date change of the exhibition due to irresistible force or other cause not resulting from the organizer, already paid exhibition fee will not be refunded and exhibitor may not ask for compensation.

Article 8. Installation(display of items) and Removal

- ① The installation and removal of the exhibits and booths must be completed by the date and time stipulated by organizer. Exhibitor shall indemnify the organizer against any loss that may be caused by delay or damage on the exhibition hall.
- ② For any damages that cannot be returned into original state, such as painting the floor/ceiling/wall, exhibitor is liable for any reasonable compensation requested by organizer regarding the restoration.
- ③ The removal of exhibits and booths must be completed by the date and time stipulated by organizer.

Article 9. Security and Safety

- ① Organizer shall take proper action 'KINTEX convention center exhibition regulation' to secure safety for the exhibitor and visitors.
- ② Exhibitor is fully liable for any damages or loss occurred during the exhibition preparation period, exhibition period and dismantling period.
- ③ If exhibitor intently caused fire, damage, loss or other accidents causing loss to organizer or any 3rd party, exhibitor is fully liable for the cause and insurance regarding all materials and items.

Article 10. Fire safety

- ① All materials and items must be fire resistant according to the safety regulations.
- ② Organizer may ask for modification regarding fire prevention to the exhibitor if necessary.

Article 11. Restriction on sound volume

Exhibitor cannot use speaker or amplifier without prior approval organizer and sales or loud activities are strictly prohibited.

Article 12. Amendment

- ① The organizer reserve the rights to modify at any time the provisions of the present rules and regulation, the exhibitors shall comply with the modification.
- ② The exhibitor must comply with the regulations of KINTEX convention center.

Article 13. Disputes

In any disputes that may arise concerning interpretation of the present terms and conditions, the exhibitor agree to the competence of the Commercial Arbitration Rules of the Korean Commercial Arbitration Board and shall not bring a law-suit against the ruling.
